

## ITINERARY

#### Day 1 – March 20: Depart USA

Our pilgrimage begins today as we depart on our flight to Israel. Meals and drinks served aloft.

## Day 2 - March 21: Arrive Tel Aviv / Netanya

After arrival at Ben Gurion Airport in Tel Aviv, we will be met at the airport and then transfer to our hotel located on the shores of the Mediterranean in Netanya.



## Day 3 - March 22: Netanya / Galilee

This morning, leave Netanya and drive north along the Mediterranean coast to Caesarea, capital of the ancient Roman Procurators of Judea. Here, St. Peter preached and St. Paul was imprisoned for two years. Visit the Roman Theater, Crusader's Moat, and the Byzantine Churches. Continue to the sparkling port city of Haifa. Ascend Mt. Carmel, home of the prophets Elijah and Elisha, to visit Stella Maris. Continue to our hotel located on the shores of the Sea of Galilee for check-in.



#### Day 4 - March 23: Galilee

Following breakfast, drive to Cana of Galilee, where Our Lord performed the first miracle - changing water into wine at the wedding feast. Here, we'll invite couples to renew their marriage vows. Proceed to Nazareth to visit the Basilica of the Annunciation. In the afternoon take an excursion to the summit of Mt. Tabor to visit the site of the Transfiguration of Jesus.



#### Day 5 - March 24: Galilee

This morning, enjoy a scenic boat ride across the Sea of Galilee to Capernaum, home of Jesus during His ministry. After visiting the synagogue where He taught, drive to Tabgha - site of the multiplication of loaves and fishes. Next, drive to the Mount of Beatitudes to visit the site of the Sermon on the Mount. The remainder of the day is free.

## Day 6 - March 25: Galilee / Jerusalem

We will depart Galilee late this morning for Jerusalem. Drive along the shores of the Sea of Galilee to the Baptismal Site on the Jordan River where we will renew our baptismal vows. Continue via the Jordan Valley to Bet Shean, where we'll view from our coach an ancient Roman amphitheater. From here, drive through the Judean wilderness to Jerusalem.



Day 7 - March 26: Jerusalem

This morning, drive to the top of the Mt. of Olives for a spectacular view of Jerusalem. Visit the Church of Pater Noster, Ascension, and then walk the "Palm Sunday Road" to Dominus Flevit, where Our Lord wept over Jerusalem. Proceed to the Garden of Gethsemane to visit the Church of All Nations. In the afternoon, drive through the New City of Jerusalem to Ein Karem, birthplace of St. John the Baptist, to see the Visitation Church where Mary proclaimed her famous "Magnificat".

#### Day 8 – March 27: Jerusalem

Drive to visit the Shepherd's Fields and then proceed to Bethlehem to visit the Nativity Church, built by the Emperor Constantine in the 4th century over the traditional grotto of Jesus' birth. Tour the Manger, the Grotto of St. Jerome, the Church of St. Catherine, and the Milk Grotto. Then visit the Franciscan Family Center followed by some free time for shopping before returning to Jerusalem.



#### Day 9 - March 28: Jerusalem

This morning, enter the Old City of Jerusalem. Visit the Church of St. Anne, the Pool of Bethesda and the Chapel of Flagellation. We will then walk along the Via Dolorosa to the Church of the Holy Sepulchre to visit Golgotha and the Tomb of Our Lord. In the afternoon proceed to Mt. Zion to visit the Upper Room, Dormition Abbey and St. Peter in Gallicantu where Peter denied Jesus three times.



## Day 10 - March 29: Jerusalem / Tel Aviv

Proceed to Bethany to visit the site of the House of Mary, Martha & Lazarus and the Tomb of Lazarus. Continue through the Judean Wilderness and along the Dead Sea to Qumran to see the caves where the Dead Sea Scrolls were discovered. We will continue on to visit Jericho, the oldest known city in the Western world. From the top of the ancient "tel", we'll have an excellent view of Elisha's Fountain, the Qarantal and the Mount of Temptation. Return to Jerusalem and enjoy a farewell dinner this evening. After dinner transfer to Ben Gurion Airport in Tel Aviv to catch your late evening return flight home.



Day 11 - March 30: Tel Aviv / USA

This morning we arrive back in the United States following our overnight flight from Tel Aviv.

#### **GENERAL INFORMATION AND CONDITIONS**

**Reservations and Payment:** A deposit of \$300.00 per person is required at the time of booking. Final payment is due 65 days prior to departure.

Cancellations: All cancellations must be in writing and cancellations received after 5:00 PM Pacific Time or on weekends/holidays will be processed the next business day. The following per person cancellation charges will apply: If canceled 91 days or more prior to departure, a \$50.00 administrative fee will be charged. If canceled 90 - 61 days prior to departure, \$250.00 will be charged. If canceled 30 - 7 days prior to departure, \$450.00 will be charged. If canceled 30 - 7 days prior to departure \$700.00 will be charged. No refunds will be made within 6 days of departure. In addition, once the airline tickets have been issued, 100% of the airfare is non-refundable unless you have been advised otherwise at the time of your booking. Additional cancellation charges may apply depending upon the cancellation terms of our suppliers.

**Refunds**: Subject to the foregoing Cancellation Terms, upon cancellation of travel related services, all sums paid to the Franciscan Foundation for the Holy Land or George's International Tours for such services will be promptly returned to the passenger, <u>provided</u> the passenger has not caused such cancellation and is not in violation of any of the terms and conditions previously, clearly and conspicuously disclosed and agreed to by the passenger. This refund provision does not apply where the Franciscan Foundation for the Holy Land or George's International Tours has remitted the payment to another registered seller of travel or a carrier and they default in providing the agreed-upon transportation or service without providing a refund. **Travel Documents:** A passport with a minimum of 6 months validity remaining is required of all U.S. citizens. U.S. citizens do not require an entry visa for entry to Israel. If you are not a U.S. citizen, please call to find out if you need an entry visa. George's International is not responsible for entry visas or passports.

**Tour Cost**: All quoted prices are based upon airfares, tariffs and currency exchange rates at the time of printing and are subject to change at any time. Should the minimum number of 30 tour members not be reached, the right is reserved to increase the tour cost accordingly.

**Tour Documents and Tickets**: Final tour documents are mailed, provided we have received full payment, within 3 weeks of departure.

**Baggage**: Each passenger is allowed one checked bag and one carry-on.
